# Safety Net Hospital Alliance of Florida Names Justin Senior New Chief Executive Officer

ORLANDO, Fla. (November 27, 2018) – In a move to further enhance its team of professionals and advance its mission of providing essential health care to Floridians, the Safety Net Hospital Alliance of Florida announced today that Justin Senior, the outgoing Secretary of the Agency for Health Care Administration, is joining the organization as its Chief Executive Officer.

Senior, who will start in his new position in January, will work alongside Lindy Kennedy, who is assuming the title of President and Chief Operating Officer.

"I look forward to ensuring our hospitals have the resources and attention they need to ensure all Floridians have access to affordable, high-quality health care."

The addition of Senior builds upon the Safety Net Alliance's longstanding mission of providing essential, highly specialized medical care to Floridians through its 14 systems of teaching, public, children's and regional perinatal intensive care hospitals located in every major region of the state.

"We are delighted that Justin is joining our already strong senior leadership team to further build upon our mission of ensuring that all Floridians have access to vital health care services, close to home," said Edward Jimenez, SNHAF board chairman and CEO of UF Health Shands. "Justin's mission-driven vision is very much aligned with our organizations', and today's announcement is good news for the Safety Nets and for patients across Florida."

Senior became AHCA Secretary in October 2016 and prior to that served as AHCA's Medicaid Director from 2011 to 2016, overseeing the procurement, implementation and operation of Florida's Statewide Medicaid Managed Care program. Before joining AHCA, he was a litigation attorney in the private sector for more than 11 years. He has a bachelor's degree from McGill University and a law degree from the University of Florida.

"Justin's background and expertise are a great match for Florida's Safety Net hospitals and will enhance our efforts to navigate today's ever changing, complicated healthcare system and stay true to our mission of caring for all residents," Kennedy said.
